4a (Code:) (Expenses \$ 27,577. including grants of \$) (Revenue \$) Translators Without Borders (TWB) translates millions of words per year to vetted NGOs. TWB focuses on three types of humanitarian translations: crisis translations needed urgently to inform people in crisis, translations which support an NGO's operations, and educational translations that directly support people in need.

During the fiscal year ended March 31, 2014, TWB volunteers translated 7.2 million words, an equivalence of \$1,440,000. Over the past two years TWB volunteers have provided translations in support of more than 119 nonprofit organizations needing translation in 99 language pairs.

4b (Code:) (Expenses \$ 120,092. including grants of \$ 120,092.) (Revenue \$) To accomplish its mission, the organization seeks to develop a community in which non-government and aid organizations can easily ensure that their constituents can understand the critical information being provided.

This fiscal year Translators without Borders continued to financially support Translators without Borders Kenya, an independently registered, non-profit East African healthcare translation center in Nairobi, Kenya. The facility has continued training a team of professional translators, giving them skills in technology and translation on par with any European or North American translators. We also expanded our training program to provide translation for community translators in
